Non-State Schools Accreditation Board

The Non-State Schools Accreditation Board was established on 21 September 2001 under the now repealed *Education (Accreditation of Non-State Schools) Act 2001*. From 1 January 2018, the Board continued operation under the *Education (Accreditation of Non-State Schools) Act 2017* (the Accreditation Act).

Vision

Excellence in education offered in non-State schools.

Purpose

- Uphold the standards of education in non-State schools
- Maintain public confidence in the operation of non-State schools
- Foster educational choice in Queensland

Contribution to government objectives

The Board contributes to the Queensland Government's objectives for the community, particularly in regard to being a responsive government agency and delivering quality frontline services in respect of achieving better education outcomes. The Board's functions include:

- Assessing and deciding applications for accreditation of non-State schools
- Determining eligibility for government funding
- Monitoring whether non-State schools continue to comply with the prescribed requirements of accreditation
- Monitoring whether governing bodies of accredited schools are suitable
- Monitoring compliance with the Accreditation Act
- Conducting investigations about contraventions of, or noncompliance with, the Accreditation Act

Strategic challenges

- Monitoring of child protection policies and written procedures, and their implementation, to ensure schools' compliance with legislation
- Assessment and monitoring schools' educational programs for consistency with the Australian Curriculum; Queensland Curriculum and Assessment Authority (QCAA) syllabuses subject/s; and alternative curriculum approaches as recognised by Australian Curriculum, Assessment and Reporting Authority (ACARA)
- The efficacy of the non-State schools' review program as the key mechanism by which schools maintain ongoing accreditation and Government-funding eligibility
- Accuracy and validity of school survey data submitted by governing bodies
- Challenges associated with ensuring compliance in a broader changing legislative environment.

Key opportunities and challenges

- Implementing operational responses to changes in relevant legislation (including *Education (General Provisions) Act 2006* and *Child Protection Act 1999*)
- Ensuring educational programs in all non-State schools maintain standards in an environment that values diversity in educational choices
- Managing an ever increasing workload for the Board and its Secretariat
- Designing effective technological and operational solutions to enhance Board efficiency.
- Investigating allegations of unaccredited education sites operating as schools
